PREFACE

The present volume undertakes to provide lists of books which will aid the professional student of the literature of the United States in the acquiring of information and in the techniques of research. It is believed that it will prove useful to college teachers of American literature, to reference librarians, and, more especially, to graduate students writing master's or doctor's theses. In its way, it is comparable to the bibliographical guides to English literature compiled by Arthur G. Kennedy, Tom P. Cross, and John W. Spargo. Their manuals, with varying emphasis and method, contain material on American as well as British literature, but their treatment of the former is relatively incidental and for sound reasons has proved unsatisfactory to Americanists. This book is the first of its kind to see print.

In addition to materials having to do with methods of research and with American literature in its several phases, essential tools are herein listed for the study of American history, biography, art, religion, philosophy, etc., not only because of the patent need for backgrounds but also because of the special interests of a large number of students or scholars who investigate the literature of the United States in interdepartmental programs usually spoken of as *American Studies* or *American Civilization*. Historians of ideas will find that their favored approach has also been recognized in the selection of titles for this guide. Calculated consideration has, furthermore, been given to American literature as a part of comparative studies, and a special section is devoted to the relationship of the national letters with foreign countries and foreign literatures. The compiler has borne in mind not only the manifest importance of foreign influences upon the *belles-lettres* of the United States but the repercussions, so to speak, of the national literature in foreign countries. It is hoped that this guide will prove helpful to such professional students of its subject as are now at work in Japan, Germany, and the other countries where American Studies constitute a part of academic curricula.

The various headings for the individual sections of the guide will usually provide sufficient direction to the reader, but indexes of subjects and of authors, compilers, or editors are appended as additional aids to the locating of information. In many cases the individual items that make up the contents of this book are recorded in "short title" style, but whenever a subtitle seemed advantageous in calling attention to the contents or purpose of a given work it has been printed.

By abandoning an alphabetical order for the works listed in this guide I have at times been able to begin the various sections with the most generally used bibliographies or to group titles which have a special affiliation. For example, in Section 32, "American Literature in Relations with Other Countries and Literatures," all the works dealing with the relationship with France appear in consecutive order rather than scattered as they would be if an alphabetical arrangement were followed. Cross-references are supplied at the ends of various sections calling attention to important items classified elsewhere, but the index of subjects will usually provide further aid in locating items dealing in part with a given topic. Very few anthologies have been included, and such as do appear are listed because of their special editorial or bibliographical contents.

The long dashes indicate that publication is still in process as of June, 1959. The dates following semicolons indicate the year of a reprinting. The reader should be warned, however, that the indication of reprints is bound to prove incomplete, for so many books of a scholarly or semi-scholarly sort are now being reproduced by offset that the record can never be kept up to date.

In assembling the materials for this guide I have had good reason to consult with a large number of experts in various fields from whose advice I have certainly profited. They are so many that I can here merely mention their names and indicate the areas in which they have helped me: John R. Alden (Duke) history, Roger M. Asselineau (Lyon) foreign studies, Harry H. To all these scholars I wish to express my gratitude, and I wish also to praise the readiness with which they answered my calls for help.

For the editorial assistance of Norman Hoyle and Ashbel Brice I am truly grateful, as I am also for the typographical advice given by John Menapace and William Owens. Special mention should be made of the services rendered by the staff of the Duke University Library, whose assistance to an inexperienced bibliographer was as invaluable as it was kindly. My gratitude is especially directed to Florence E. Blakely, Mary W. Canada, and Mary Frances Morris, Reference Librarians without peers in patience. And, finally, I bow in admiration as well as gratitude to Constance Winchell, Reference Librarian of

the Columbia University Library, whose compilations so often have served as my bibliographical Bible.

1. AIDS TO INFORMATION ON ALL SUBJECTS

- 1.1** Besterman, Theodore. A world bibliography of bibliographies: and of bibliographical catalogues, calendars, abstracts, digests, indexes, and the like. 3d ed. 4 v. Geneva, [1955-1956].

International in scope, this work lists by subjects separately published bibliographies in all fields—from “academic writings” to “zoology.” V. 4 is an index. This is the most comprehensive bibliographical guide available.

- 1.2** Bibliographic index: a cumulative bibliography of bibliographies 1937——. N.Y., 1945——.

Issued quarterly; cumulated annually. Separate bibliographies and bibliographies in books as well as in about 1500 periodicals are listed under several thousand different headings.

- 1.3** Winchell, Constance. Guide to reference books. 7th ed. Chicago, 1951. Supplements, Chicago, 1954, 1956.

Standard guide to reference works on all subjects; periodically revised and brought up to date.

- 1.4** Malclès, Louise N. Les sources du travail bibliographique. 4 v. Geneva and Lille, 1950.

A well-indexed general bibliographical guide. V. 2 and 3 are principally concerned with the humanities, and v. 4 with the exact sciences and technology.

- 1.5** Murphey, Robert W. How and where to look it up: a guide to standard sources of information. N.Y., [1958]

Contains numerous subject headings for more than ten thousand annotated reference sources. Explanations of the ways to use them are prepared for the layman's needs. Often uneven and inaccurate in details.

- 1.6** American Library Association index . . . to general literature. 2d ed. Boston and N.Y., 1901. Supplement, Chicago, 1914.

Subject classification of books in English devoted to essays and other factual works, including biography, literary and art criticism, history, and other social studies. The first volume covers books published before 1900; the supplement, books published 1900-1910. Predecessor to the following item.

- 1.7** Essay and general literature index, 1900——. N.Y., 1934——.

Now kept up to date by regularly appearing supplements; all materials indexed have appeared in book form.

- 1.8** Library of Congress catalog: a cumulative list of works represented by Library of Congress cards: books: subjects 1950-1954. 20 v. Ann Arbor, Mich., 1955.

Since 1955 continued with the Library of Congress as publisher. Books from the U.S. or abroad received by the Library of Congress or co-operating libraries are classified alphabetically under headings such as "American Wit and Humor," "English Drama," "French Literature," "Zoological Parks." (Very useful also is *The British National Bibliography 1950—: A Subject List of the New British Books Published in 1950—*, ed. A. J. Wells, London, [1951]—.)

- 1.9** The cumulative book index: a world list of books in the English language. N.Y., 1933—.

An author-title-subject catalog in one alphabet of books in English published in all parts of the world since January 1, 1929.

- 1.10** Subject guide to books in print: an index to the Publishers' Trade List Annual 1957—. N.Y., [1957]—.

Under more than 20,000 topics or headings, the works currently listed in the catalogs of all the principal U.S. publishers are recorded; volumes of poetry and plays by a single author are omitted.

- 1.11** American library directory. 21st ed. N.Y., 1957.

A classified list of 14,260 libraries with names of libraries, and statistical data; compiled triennially.

- 1.12** Ash, Lee. Subject collections: a guide to special book collections and subject emphases as reported by university, college, public and special libraries in the U.S., the Territories, and Canada. N.Y., 1958.

The intention is to revise this work triennially.

- 1.13** Winchell, Constance M. Locating books for interlibrary loan: with a bibliography of printed aids which show the location of books in American libraries. N.Y., 1930.

The bibliography is very limited and out of date. See various printed catalogs of libraries and, for newspapers and serials, 12.2, 13.5 (Gregory).

- 1.14** Bulletin of bibliography. April, 1897—.

A periodical which specializes in publishing checklists and records of magazines newly started or ended. From October, 1909, to May-August, 1953, it carried a quarterly Dramatic Index of periodical articles (chiefly from popular magazines) concerned with all aspects of the theater.

- 1.15** Union list of microfilms. Rev., enlarged, and cumulated ed. Ann Arbor, Mich., 1951.

Supplements keep this record closer to date. Co-operating libraries report their microfilm accessions for this work. Theses from American universities are no longer included. (See *Dissertation Abstracts*, formerly *Microfilm Abstracts*.)

- 1.16** Doctoral dissertations accepted by American universities 1933-34—1954-55. 17 v. N.Y., 1934-1955.

Covers doctoral theses in all fields. The preliminary matter in each volume contains a list of current university serials which publish abstracts of theses. Superseded by "Index to American Doctoral Dissertations," in the following item, v. 16, no. 13—. (For a special list in American literature, see 20.9, Woodress.)

- 1.17** Dissertation abstracts: a guide to dissertations and monographs available on microfilm. (Originally entitled Microfilm abstracts.) Ann Arbor, Mich., 1938—.

The number of co-operating universities has greatly increased, and this compilation of abstracts of dissertations which have been microfilmed now appears monthly. The Index is the standard current list of dissertations in all fields accepted by American universities.

- 1.18** Keller, Helen R. The dictionary of dates. 2 v. N.Y., 1934.

- 1.19** Zaunmüller, Wolfram. Bibliographisches Handbuch der Sprachwörterbücher. Stuttgart, 1958.

More than 5,600 dictionaries covering about 600 languages are listed.

2. PHILOSOPHY AND GENERAL METHODOLOGY OF LITERARY AND HISTORICAL STUDY

- 2.1** Wellek, René, and Warren, Austin. *Theory of literature*. N.Y., [1949]; 1956.

Describes and criticizes the various methods of, and approaches to, the study of literature, with generalizations on literary theory, evaluation, research, and history. An excellent international bibliography is appended, with the following subtopics: "Literature and Literary Study," "The Nature of Literature," "The Function of Literature," "Literary Theory, History, and Criticism," "National, Comparative and General Literature," "The Ordering and Establishing of Evidence," "Literature and Biography," "Literature and Psychology," "Literature and Society," "Literature and Ideas," "Literature and the Other Arts," "The Analysis of the Literary Work of Art," "Euphony, Rhythm, and Meter," "Style and Stylistics," "Image, Metaphor, Symbol, and Myth," "The Nature and Modes of Fiction," "Literary Genres," "Evaluation," "Literary History," and "The Study of Literature in the Graduate School." The 1956 reprint drops the final chapter and occasionally brings the bibliography nearer to date.

- 2.2** Greenlaw, Edwin. *The province of literary history*. Baltimore, [1931].

Literary history is viewed as a province distinct from that of criticism or literary biography, and certain of its problems and methods are set forth

- 2.3** Boas, George. "Some problems of intellectual history." *Studies in intellectual history*, pp. 3-21. [Baltimore], 1953.

Points out "some of the peculiarities of historiography" and some of its problems as they pertain to the history of ideas.

- 2.4** Langlois, Charles V., and Seignobos, Charles. *Introduction to the study of history*. Tr. by G. G. Berry. N.Y., [1926].

- 2.5** Jones, Howard M. *The theory of American literature*. Ithaca, N.Y., 1948.

Attitudes pervading scholarship on American literature from Colonial times to the present are briefly surveyed.

- 2.6** Hockett, Homer C. *The critical method in historical research and writing*. N.Y., [1955].

Both a bibliography of essential tools and a lucid guide to research in American history. Part II, "The Master's Essay," describes the processes of

finding and developing a topic, note taking, outlining, making a bibliography, etc. Included also are brief surveys of American historiography, of the historical projects of the WPA and of the armed services, and of the various types of U.S. government publications. Much of the discussion of method is as pertinent for the student of literature as for the student of history. The list of chief bibliographies dealing with the history of the various regions and the several states (pp. 281-295) is especially helpful. (For methodology in the study of American history, see also the first chapters of 9.1, *Harvard Guide*.)

- 2.7** Sanders, Chauncey. An introduction to research in English literary history. N.Y., [1952].

Many of the illustrations of problems in editing, source study, etc., are taken from the American field. Part 4, "Suggestions on Thesis-writing" is elementary but clear-cut.

- 2.8** Morize, André. Problems and methods of literary history, with special reference to modern French literature: a guide for graduate students. Boston and N.Y., [1922].

Valuable for students of literature in any language, since it surveys the techniques employed in scholarly research.

- 2.9** Vigneron, Robert. Explication de textes, and its adaptation to the teaching of modern languages. Chicago, [1928].

Reprinted from *Modern Language Journal* for October, 1927. Outlines the system of *explication* as developed in France.

- 2.10** Hays, Edna. The college teaching of English: a bibliography 1941-1944. Pamphlet publication No. 8 of the National Council of Teachers of English. Chicago, [1946].

Continued annually in the May numbers of *College English*, 1947-1950; renewed in the October, 1957, issue with list covering 1954-1956.

- 2.11** Richards, Ivor A. Practical criticism: a study of literary judgment. London and N.Y., 1929; 1956.

This work is the grandfather, if not the father, of a considerable element in the recent analytical study of poetry.

3. TECHNICAL PROCEDURES IN LITERARY AND HISTORICAL RESEARCH

- 3.1** Studies in bibliography papers of the Bibliographical Society of the University of Virginia, 1947—. Charlottesville, Va., 1948—.

An annual devoted to bibliographical studies pertaining especially to English and American literature. Regularly includes a selective checklist of bibliographical scholarship published during the preceding year, with emphasis on printing, publishing, and textual studies. The checklists for 1949-1955 have been assembled in a decennial extra volume, v. 10, 1957.

- 3.2** Bowers, Fredson. Principles of bibliographical description. Princeton, N.J., 1949.

A standard work on the methods of analyzing a book with a view to making a scientific description of it as a physical entity. Offers expert technical explanations of such matters as edition, impression, issue, state, format. Of special interest is the section on books of the 19th and 20th centuries.

- 3.3** Esdaile, Arundell. A student's manual of bibliography. Revised by Roy Stokes. 3d rev. ed. London, [1954].

History of printing, methods of collating and describing books, types and arrangement of bibliographies. Often outmoded by Bowers. (For a model arrangement of an extensive single-author bibliography, see Thomas F. Currier, *A Bibliography of J. G. Whittier*, Cambridge, Mass., 1937).

- 3.4** Parker, Donald. Local history: how to gather it, write it, and publish it. Rev. and ed. by Bertha E. Josephson. N.Y., 1944.

Useful for the study of minor authors of regional interest.

- 3.5** Osborn, James M. "The search for English literary documents." English institute annual for 1939. N.Y., 1940.

Many bits of advice herein contained are applicable also to the student of Americana.

- 3.6** Haselden, Reginald B. Scientific aids for the study of manuscripts. [Oxford], 1935.

Contains much material on general procedures involved in studying MSS.

- 3.7** Greg, Walter W. The calculus of variants: an essay on textual criticism. Oxford, 1927.

A scientific treatise on the establishment of relationships among manuscripts of a given work and on the problems of handling variants.

- 3.8** Halsband, Robert. "Editing the letters of letter-writers." *Studies in bibliography*, v. 11, pp. 25-37 (1958).

Practical suggestions for handling problems presented by the editing of collections of letters. (For a splendid example of techniques applied, see *The Letters of R. W. Emerson*, ed. R. L. Rusk, 6 v., N.Y., 1939.)

- 3.9** Lewis, Chester M., and Offenhauser, William H, Jr. *Microrecording*. N.Y., [1956].

Description of various kinds of microrecording and copying devices and methods, including xerography. See also *Library Trends*, January, 1960.

- 3.10** Halkett, Samuel, and Laing, John. *Dictionary of anonymous and pseudonymous English literature*. New ed. Ed. James Kennedy *et al.* 8 v. Edinburgh and London, 1926-[1956].

Many American works are included, especially in v 8, which covers 1900-1949. This work is a standard one for English literature, from earliest times.

- 3.11** Cushing, William. *Anonyms: a dictionary of revealed authorship*. Cambridge, Mass., 1889.

A standard work for English and American anonymous titles of the 18th and 19th centuries. (For a list of handbooks dealing with anonymously or pseudonymously published works, in various languages, see Adah H. Morris, "Anonyms and Pseudonyms an Annotated List," *Library Quarterly*, v 3, pp 354-372, October, 1933.)

- 3.12** Garraty, John A. *The nature of biography*. N.Y., 1957.

Discusses the historical development of biography as a genre and contains a section on methods of preparing biographies. The list of sources is helpful.

4. DEFINITIONS OF LITERARY AND RELATED TERMS

- 4.1** Wolf, Martin L. Dictionary of the arts. N.Y., [1951].

Briefly defines many terms used in literature, ballet, architecture, music, painting, etc.

- 4.2** Shipley, Joseph T., ed. Dictionary of world literature: criticism, forms, technique. Rev. ed. N.Y., [1953]; Paterson, N.J., 1959.

Definitions of critical terms, with brief outlines of literary criticism in various individual countries.

- 4.3** Norton, Dan S., and Peters, Rushton. Rev. by Meyer H. Abrams. A glossary of literary terms. N.Y., [1957].

The definitions are often elementary, but clear.

- 4.4** Thrall, William F., and Hibbard, Addison. A handbook to literature. Rev. by C. Hugh Holman. N.Y., [1960].

Chiefly words and phrases "as found in criticism, rhetoric, literary history, and versification, including terminology reflecting efforts to classify literature by types, forms, and traditions."

- 4.5** Thompson, Elizabeth H. American Library Association glossary of library terms: with a selection of terms in related fields. Chicago, 1943.

- 4.6** Barnhart, Clarence L., ed. The new Century handbook of English literature. N.Y., [1956].

Contains entries on authors, titles, and characters from works of literature, etc.; includes a fair number of clear definitions.

- 4.7** Harvey, Paul. The Oxford companion to English literature. 3d ed. Oxford, 1946.

A standard handbook for the study of English literature.

- 4.8** Yelland, H. L., *et al.* A handbook of literary terms. Sydney, Australia, and N.Y., [1950].

- 4.9** Bookman's glossary. 3d ed. rev. N.Y., [1951].

Guide to terminology "used in the production and distribution of books new and old." A brief list of works on subjects reflected in the glossary appears as an appendix.

4.10 Carter, John. *ABC for book-collectors*. N.Y., [1951].

Definitions, with occasional comment, of such words and phrases as would be likely to puzzle a student facing for the first time a bookseller's or auctioneer's catalog.

4.11 The bookman's concise dictionary. London, [1956].
Useful for British terms.

4.12 Deutsch, Babette. *Poetry handbook: a dictionary of terms*. N.Y., [1957].

The definitions are elementary and clear. (Works on versification usually aid greatly in defining poetical terms, e.g., George R. Stewart, Jr., *The Technique of English Verse*, N.Y., [1930]; Paul F. Baum, *The Principles of English Versification*, Cambridge, Mass., 1922; 1923. For others, see 22.16, Karl Shapiro).

See also 35.9-14.

5. PREPARATION OF MANUSCRIPTS FOR PUBLICATION

- 5.1** On the publication of research: essays by R. B. McKerrow and Henry M. Silver. Reprinted from PMLA, v. 65 (April, 1950). N.Y., [1950].

Brief practical instructions on how to organize an article, how to prepare the MS, and principles to follow in reading proof.

- 5.2** The MLA style sheet. Comp. William R. Parker. Rev. ed. N.Y., [1954].

Directions for preparing MSS, footnotes, and bibliographies for theses. The style suggested here is used by a large number of scholarly journals. (The pamphlet may be obtained from the Modern Language Association of America, 6 Washington Square North, N.Y. 3.)

- 5.3** A manual of style. By the staff of the University of Chicago press. 11th rev. ed. Chicago, 1949.

Rules for preparation of copy, suggestions for editing, glossaries of technical terms, specimens of type, etc. This work is widely used by magazine and book publishers.

- 5.4** Von Ostermann, Georg F. Manual of foreign languages. 4th ed. rev. N.Y., 1952.

Editorial manual indicating peculiarities of capitalization, accents, abbreviations, numerals, etc. for a large and diverse list of languages.

- 5.5** Nicholson, Margaret. A manual of copyright practice for writers, publishers, and agents. 2d ed. N.Y., 1956.

"What to do in a specific situation involving copyright."

- 5.6** Wittenberg, Philip. The law of literary property. Cleveland and N.Y., [1957].

On American laws concerning copyright, libel, permissions for quotations, censorship, etc.

- 5.7** Spiker, Sina. Indexing your book: a practical guide for authors. Madison, Wis., 1955.

- 5.8** Byrd, Milton B., and Goldsmith, Arnold L. Publication guide for literary and linguistic scholars. Detroit, 1958.

Lists 180 journals, chiefly of interest to scholars in English and American literature, with subscription data, editorial policies, and information on the nature and handling of MSS.

- 5.9** American journals in the humanities: a guide to scope and editorial policy. Reprinted from *PMLA*, v. 72 (September, 1957). N.Y., [1957].

The policies of 48 periodicals. Addresses of the editorial offices and names of editors appear regularly in *PMLA*'s "Directory of Useful Addresses," appended to its annual list of members (September).

- 5.10** The literary market place. N.Y., 1940——.

Annual directory which arranges American publishers by location and by type of books published. It also supplies lists of national associations, literary awards, columnists, radio book programs, magazines and newspapers containing book news, etc.

6. LIBRARY OF CONGRESS CATALOGS AND CHIEF REGISTERS OF U. S. PUBLICATIONS

- 6.1** A catalog of books represented by Library of Congress printed cards issued to July 31, 1942. 167 v. Ann Arbor, Mich., 1942-1946.

Photographic reproduction of nearly two million cards, alphabetically arranged. Not all the books represented by the cards are in the Library of Congress. This work does not cover all the holdings of the Library of Congress—but only such works for which cards were printed—from August, 1898, to 1942.

- 6.2** ——— Supplement: cards issued August 1, 1942—December 31, 1947. 42 v. Ann Arbor, Mich., 1948.

- 6.3** The Library of Congress author catalog: a cumulative list of works represented by Library of Congress printed cards 1948-1952. 24 v. Ann Arbor, Mich., 1953.

V. 24 lists motion pictures and film strips.

- 6.4** The national union catalog: a cumulative author list representing Library of Congress printed cards and titles reported by other American libraries 1953-1957. 28 v. Ann Arbor, Mich., 1958.

The last two volumes register music, phonorecords, motion pictures, and film strips. Since 1956 includes “not only Library of Congress cards but also cards representing titles with 1956 or later imprints reported to the National Union Catalog by other North American libraries, together with locations of all such titles reported to the National Union Catalog.” Continued serially as *National Union Catalog*.

- 6.5** Evans, Charles. American bibliography: a chronological dictionary of all books, pamphlets and periodical publications printed in the U.S. . . . 1639- [1800]. 13 v. Chicago, 1903-1955.

V. 13, edited by Clifford K. Shipton, was published in Worcester, Mass. A number of “ghost” titles appear, especially in the earlier volumes. (The American Antiquarian Society is in process of reproducing in microprint all the available works listed in Evans.)

- 6.6** Waters, Willard O. American imprints, 1648-1797, in the Huntington Library, supplementing Evans' American Bibliography. [Cambridge, Mass., 1933].

Reprinted from *Huntington Library Bulletin*, no. 3 (February, 1933).

- 6.7** Shaw, Ralph R., and Shoemaker, Richard H. *American bibliography. a preliminary checklist for 1801—*. N.Y., 1958—.

Compiled entirely from secondary sources, this makes a tentative step in filling the gap in the listing of American publications for the period 1801-1819 inclusive. The entries are uneven in quality, but the locations of copies are included. (For this period there are also many state or regional lists of imprints.)

- 6.8** Growoll, Adolf. *Book-trade bibliography in the U.S. in the 19th century*. N.Y., 1898; [1939].

Lists the chief older sources of information on works printed in the U.S. during the century.

- 6.9** Sabin, Joseph. *Bibliotheca Americana: a dictionary of books relating to America, from its discovery*. . . . 29 v. N.Y., 1868-1936.

Includes works published in America and about America printed elsewhere. Arrangement is alphabetical. In later volumes the scope is materially reduced. Like Evans, this often mentions libraries owning copies, and hence is useful for interlibrary loans.

- 6.10** Roorbach, Orville A. *Bibliotheca Americana, 1820-1861*. 4 v. N.Y., 1852-1861; 1939.

Catalog of publications, including reprints, arranged by authors and titles, giving publisher, date, price. By no means are all American published works of the period listed.

- 6.11** Kelly, James. *American catalogue of books published in the U.S. from January, 1861 to January, 1871*. 2 v. N.Y., 1866-1871; 1938.

Like Roorbach, far from complete.

- 6.12** *The American catalogue, 1876-1910*. 9 v. in 13. N.Y., 1876-1910; 1941.

(For the gap between 1872 and 1876, see *Publishers' Weekly*, 1872-1876.)

- 6.13** *Annual American catalogue, 1869-1872, 1886-1910*. 25 v. N.Y., 1887-1911.

Inferior to, but sometimes supplementary to, *American Catalogue*.

- 6.14** *The United States catalog: books in print*. Minneapolis and N.Y., 1900—.

Since 1928 lists also certain publications in English outside the U.S.

- 6.15** *Cumulative book index*. N.Y., 1898—.

Periodically issued to form supplements to *United States Catalog*.

- 6.16** *Publishers' weekly, 1872—*. N.Y., 1872—.

Lists new publications weekly. *American Book Publishing Record*, N.Y., 1960— cumulates monthly and arranges the new publications by subject. *Books to Come*, N.Y., 1960— reports titles of works in advance of publication, classified by subject.

- 6.17** Books in print: an author-title-series index to the Publishers' Trade List Annual. N.Y., 1948——.

Registers by authors and then by titles all the books listed for sale in the current catalogs of the vast majority of American publishers.

- 6.18** Paperbound books in print. N.Y., 1955——.

Serially issued by the R. R. Bowker Co. Indexed by subject, author, and title. American publishers only.

7. INDEXES TO CONTENTS OF MAGAZINES

- 7.1** Poole's index to periodical literature, 1802-1907. 7 v. in 6. N.Y., 1938.

Subject index only.

- 7.2** Cushing, Helen G., and Morris, Adah V. Nineteenth century readers' guide to periodical literature, 1890-1899: with supplementary indexing 1900-1922. 2 v. N.Y., 1944.

Fifty-one British and American magazines are covered for the nineties, and fourteen are continued beyond 1899. Many anonymous contributors are identified.

- 7.3** Readers' guide to periodical literature, 1900——. Minneapolis, etc., 1905——.

- 7.4** International index to periodicals, devoted chiefly to the humanities and science, 1907——. N.Y., etc., 1916——.

- 7.5** Annual magazine subject index, 1907-1949. 43 v. Boston, 1908-1952.

About half of the magazines covered relate to history, especially American local history. Also contains *Dramatic Index* of books and articles on drama and theater.

- 7.6** The book review digest, 1905——. N.Y., 1906——.

Excerpts from the early reviews of selected newly published books. The periodicals covered are largely general organs like weeklies that review books fairly soon after they appear. Helpful in obtaining a cursory view of contents of books and a sampling of the reviewers' reactions to them.

- 7.7** Index to little magazines, 1948——. Denver, 1949——.

Sporadic publication, for the most part annual. Covers primarily literary contents of selected "little" magazines which are not indexed in *Readers' Guide* or *International Index*.

- 7.8** Index to early American periodical literature, 1728-1870. N.Y., 1941.

Describes a card index, compiled by WPA, housed at New York University and available for the use of scholars.

- 7.9** O'Neill, Edward H. A description and an analysis of the bibliography of American literature. Philadelphia, 1941.

Describes a card index, compiled by WPA, housed at the University of Pennsylvania and available for the use of scholars. Like the N.Y.U. index, this is very useful in making lists of works by minor authors published in older American periodicals.

- 7.10** Haskell, Daniel C. A checklist of cumulative indexes to individual periodicals in the New York Public Library. N.Y., 1942.

Helps to answer questions like, "Is there a published index to the contents of the *Atlantic Monthly*?"

- 7.11** Ulrich's periodical directory: a classified guide to a selected list of current periodicals, foreign and domestic. Ed. Eileen C. Graves. 9th ed. N.Y., 1959.

Tells where the periodicals are indexed and brings Haskell up to date for cumulative indexes of individual magazines.

- 7.12** Abstracts of English studies. 1958——.

Monthly publication abstracting articles in a variety of professional journals of interest to students of English and American literature and the English language.

8. AMERICAN STUDIES OR AMERICAN CIVILIZATION

8.1 American quarterly. 1949——.

Official organ of the American Studies Association. A supplementary issue lists annually dissertations in progress in the field of American Studies, articles of an interdisciplinary sort, and works on the theory and teaching of American Civilization. The ASA also issues *American Studies*, primarily a pedagogical newsletter.

8.2 Walker, Robert H. American studies in the U.S.: a survey of college programs. Baton Rouge, La., [1958].

Provides information on the various American Studies programs and discusses the movement as a whole; contains bibliography.

8.3 McDowell, Tremaine. American studies. Minneapolis, 1948.

Courses in American Civilization, etc. as included in college curricula of the 1940's.

8.4 American literature in the college curriculum. By a committee on the college study of American literature and culture of the National Council of Teachers of English. Chicago, 1948.

Analysis of courses in the subject offered in 1946 and a study of the growth of American Civilization programs.

8.5 Bowden, Edwin T., ed. American studies: problems, promises and possibilities. Austin, Texas, 1958.

A panel discussion which deals informally with a number of general matters, particularly the organization of courses.

8.6 Smith, Henry N. "Can 'American Studies' develop a method?" *American quarterly*, v. 9, pp. 197-208 (Summer, 1957).

8.7 Mugridge, Donald H. American history and civilization: a list of guides and annotated or selective bibliographies. 2d ed. Washington, 1951.

A pamphlet, issued by the Library of Congress, listing 109 items. The *Harvard Guide* (9.1), of course, provides a much ampler listing.

8.8 Weimer, David R. Bibliography of American culture 1493-1875. Ann Arbor, Mich., 1957.

An uneven selective list of Americana intended for microfilming. "The film series includes microreproductions of some 5000 books and pamphlets on

American culture before 1876." This work lists all of the filmed items and about 1500 others "relevant to the period but reprinted after 1900." The items are classified under various headings grouped under Humanities, Social Sciences, and Natural or Physical Sciences. (For lists of Americana micro-filmed see the catalogs of University Microfilms, Ann Arbor, Mich.)

- 8.9** Skard, Sigmund. *American studies in Europe: their history and present organization*. 2 v. Philadelphia, [1958].

Describes seminars, institutes, and programs concerned with the U S in various European countries. Also contains much information on the reception of American literature in Europe in days gone by.

- 8.10** Newsletter of the European Association for American Studies. 1955——.

The Association was founded in 1954 at a meeting in Salzburg. The British Association for American Studies (founded 1955) also publishes a *Bulletin* (1956——) and plans to bring out a bibliographical survey of sources for American Studies in the United Kingdom, including MSS.

- 8.11** *Jahrbuch für Amerikastudien*. Heidelberg, 1956——.

Official annual of the German Society for American Studies, chiefly devoted to articles on literature and history. Contains also reviews, bibliographies, and lists of dissertations. The German SAS also issues a *Mitteilungsblatt*, which contains bibliography and lists of dissertations, as well as information about the activities of the various institutes and seminars concerned with American Studies. (German dissertations on English and American literature are periodically listed also in *Zeitschrift für Anglistik und Amerikanistik*, 1953——, published in East Germany.)

- 8.12** *Studi Americani*. Rome, 1955——.

An annual devoted to the literature and art of the U.S. Some of the articles are in English.

9. AMERICAN HISTORY: GENERAL TOOLS

- 9.1** Harvard guide to American history. Ed. Oscar Handlin *et al.* Cambridge, Mass., 1954.

Extensive lists of works on all phases of the subject, clearly arranged and well indexed. Coverage to 1951. Preliminary chapters deal with the nature of the historian's task and preparation for research and writing.

- 9.2** Beers, Henry P. Bibliographies in American history: guide to materials for research. 2d ed. N.Y., 1942.

Often outmoded by the *Harvard Guide*, but still useful because of its independent index and arrangement.

- 9.3** Writings on American history, 1902——. 1904——.

A series of volumes, published annually, with a few gaps, containing a list of books and important articles on all phases of American history. See item immediately following.

- 9.4** Index to the writings on American history 1902-1940. Compiled for the American Historical Association. Washington, [1956].

Contains references and subject classifications not to be found in the separate indexes of the annual volumes.

- 9.5** American historical review. 1895——.

Official organ of the American Historical Association, largely devoted to current bibliography and reviews of books, including extensive lists of current books and articles on the history of the U.S. and its various sections.

- 9.6** Mississippi Valley historical review. 1914——.

The chief journal devoted solely to American history; essays, book reviews, bibliographical notices, and checklists of articles, the last not so inclusive as similar lists in *American Historical Review*.

- 9.7** List of doctoral dissertations in history in progress or completed at colleges and universities in the U.S. since 1955. Washington, [1958].

This list is now published triennially by the American Historical Association. The 1955 listing included only dissertations in progress.

- 9.8** Billington, Ray A. Guides to American history manuscript collections in libraries of the U.S. N.Y., 1952.

Reprinted from *Mississippi Valley Historical Review*, v. 38, no. 3 (December, 1951). Cf. also the lists of guides to manuscript materials in *Harvard Guide*, pp. 79-88.

- 9.9** Morison, Samuel E., and Commager, Henry S. *The growth of the American republic*. Rev. ed., 2 v. N.Y., [1950].

One of the most widely used basic textbooks.

- 9.10** Schlesinger, Arthur M., and Fox, Dixon R., eds. *A history of American life*. 13 v. N.Y., 1927-1948.

The most extensive social history of the U.S. The individual volumes, written by various authors, are uneven in quality and coverage. Contains critically annotated bibliographies for all chapters.

- 9.11** Adams, James T., ed. *Dictionary of American history*. 5 v. plus index. 2d rev. ed. N.Y., 1946.

- 9.12** Morris, Richard B., ed. *Encyclopedia of American history*. N.Y., [1953]

A basic chronology is followed by a topical outline, plus biographical data on 300 notable Americans. One of the best chronological outlines of American "Civilization."

- 9.13** Carruth, Gorton, *et al.*, eds. *The encyclopedia of American facts and dates*. 2d ed. N.Y., [1959].

Includes listings through 1958 and is very fully indexed.

- 9.14** *The pageant of America: a pictorial history of the U.S.* Ed. Ralph H. Gabriel *et al.* 15 v. [New Haven, Conn., 1925-1929].

The most extensive pictorial survey, from Indians to football.

- 9.15** Adams, James T., ed. *Album of American history*. 5 v. N.Y., 1944-1949.

Pictures illustrating the social history of the U.S. from Colonial times to the 1940's. (For other pictorial records see *Harvard Guide*, pp. 64-68.)

- 9.16** *Historical statistics of the U.S. 1789-1945*. Prepared by the Bureau of the Census with the cooperation of the Social Science Research Council. [Washington], 1949.

For more recent data, including revisions, see *Statistical Abstract of the U.S.*, Washington, 1949——.

- 9.17** Paullin, Charles O. *Atlas of the historical geography of the U.S.* Ed. John K. Wright. [Washington and N.Y.], 1932.

- 9.18** Peterson, Clarence S. *Bibliography of county histories of the 3111 counties in the 48 states*. Baltimore, 1946.

A supplement adding material to 1950 appeared in Baltimore, 1950.

- 9.19** *Directory of historical societies and agencies in the U.S. and Canada 1956*. Columbus, Ohio, 1956.

Names, addresses, and titles of officers to whom correspondence should be addressed.

- 9.20** Crittenden, Christopher, and Godard, Doris. *Historical societies in the U.S. and Canada*. Washington, 1944.

Mentions their publications, general contents of their libraries and collections, etc.

- 9.21** Kraus, Michael. The writing of American history. Norman, Okla., [1953].

The chief work on American historiography.

- 9.22** Hutchinson, William T., ed. The Marcus W. Jernegan essays in American historiography. Chicago, [1937], [N.Y., 1958].

Twenty-one historians of Americana are treated by various authors.

- 9.23** Theory and practice in historical study: a report of the committee on historiography. Social Science Research Council bulletin, no. 54. N.Y., [1946].

Chapter 6, "Selective Reading List on Historiography and the Philosophy of History," includes many works by Americans

- Deals with immigration from Europe.
- 10.9** Bowers, David F., ed. Foreign influences in American life: essays and critical bibliographies. Princeton, N.J., 1944.
- A symposium, with a cursory chapter on "The American Literary Expatriate." The bibliographies cover immigration, the pattern of assimilation, the economic impact, the political impact, the artistic and literary impact, and the religious and philosophic impact.

- 10.10** Jaffe, Bernard. *Men of Science in America*. Rev. ed. N.Y., 1958.
Semi-popular, biographical treatment.
- 10.11** Bode, Carl. *The American lyceum: town meeting of the mind*. N.Y., 1956.
A history of the lyceum movement.
- 10.12** Taylor, George R., ed. *The Turner thesis concerning the role of the frontier in American history*. Boston, [1949].
Two essays by Frederick Jackson Turner are followed by discussions pro and con, in a volume included in the series *Problems in American Civilization*, edited from Amherst College. Turner has been a vital influence on historical studies of a wide variety, including literary history. Cf. 29.9 (Lucy L. Hazard).
- 10.13** Parry, Albert. *Garrets and pretenders: a history of Bohemianism in America*. N.Y., 1933.
A popular but incomplete account.
- 10.14** Filler, Louis. *Crusaders for American liberalism*. N.Y., [1939], Yellow Springs, Ohio, [1950].
History of the muckraking movement 1900-1915.
- 10.15** Cubberley, Elwood P. *Public education in the US*. Rev. ed. Boston, [1934].
A standard history of its subject.
- 10.16** Hofstadter, Richard, and Hardy, C. DeWitt. *The development and scope of higher education in the U.S.* N.Y., 1952.
Contains a succinct historical sketch. (There is a selective list of histories of various individual colleges and universities in Richard J. Storr, *The Beginnings of Graduate Education in America*, [Chicago, 1953].)
- 10.17** Schmidt, George P. *The liberal arts college: a chapter in American cultural history*. New Brunswick, N.J., 1957.

- 11.1** Riches, Phyllis M. An analytical bibliography of universal collected biography, comprising books published in the English tongue in Great Britain and Ireland, America and the British dominions. London, 1934.

- 11.2** Biography index: a cumulative index to biographical material in books and magazines. N.Y., 1946——.

Quarterly index covering books and 1500 periodicals in English, chiefly American; includes obituaries and some fictional treatments.

- 11.3** The new Century cyclopedia of names. Ed. Clarence L. Barnhart *et al.* 3 v. N.Y., [1954].

A standard reference work for names of consequence of various nationalities.

- 11.4** Dictionary of American biography. 20 v. plus index, plus supplement (1944). N.Y., 1928-1937; 1946. 2d supplement, 1958.

Each sketch is followed by a list of sources, often including MS material. The following sometimes offer sketches of individuals not represented in the DAB: *Appleton's Cyclopaedia of American Biography*, 7 v., N.Y., 1887-1900 (v. 8, 1918, is an index); *Lamb's Biographical Dictionary of the U.S.*, 7 v., Boston, 1900-1903; *The National Cyclopaedia of American Biography*, 35 v., N.Y., 1892-1949 (in progress); *White's Conspectus of American Biography*, 2d ed., N.Y., 1937. (For series of more specialized biographies, see *Harvard Guide*, pp. 188 ff.)

- 11.5** O'Neill, Edward H. Biography by Americans 1658-1936: a subject bibliography. Philadelphia, 1939.

A checklist of biographies individual and collective written by Americans. In the cases of particularly famous men only the "important books" on them are recorded.

- 11.6** Dargan, Marion. Guide to American biography. Part 1, 1607-1815; part 2, 1815-1933. Albuquerque, N. Mex., 1949-1952.

Selective; arranged by chronological periods, subdivided by geographical regions.

- 11.7** Lillard, Richard G. American life in autobiography: a descriptive guide. Stanford, Calif., [1956].

Selected autobiographies are listed under headings made according to the

profession or occupation of the writers, e.g., "Actors and Show People," "Journalists, Newspaper and Magazine Editors."

- 11.8** Matthews, William. *American diaries*. Berkeley and Los Angeles, 1945.

List of published diaries written prior to 1861.

- 11.9** Kunitz, Stanley J., and Haycraft, Howard, eds. *American authors, 1600-1900*. N.Y., 1938.

Contains 1300 biographical sketches and 400 portraits.

- 11.10** Adams, Oscar F. *A dictionary of American authors*. 5th ed. rev. and enlarged. Boston, 1905.

- 11.11** Burke, W. J., and Howe, Will D. *American authors and books 1640-1940*. N.Y., 1943.

Brief sketches; lists many very minor names.

- 11.12** Duyckinck, Evert A., and Duyckinck, George L. *Cyclopaedia of American literature*. Rev. ed. 2 v. Philadelphia, 1875.

Useful only for minor earlier writers.

- 11.13** Wallace, W. Stewart. *A dictionary of North American authors deceased before 1950*. Toronto, [1951].

The authors may be journalists, lawyers, merchants, etc., but many literary men are listed, by field of interest, with places and dates of birth and death.

- 11.14** Kunitz, Stanley J., and Haycraft, Howard. *Twentieth century authors*. N.Y., 1942. First supplement. N.Y., 1955.

Biographical sketches of 1850 authors of various nationalities, but chiefly American, plus 1700 portraits. The supplement adds about 700 new authors, usually those who have come into prominence since 1942

- 11.15** *Who's who in America*. Chicago, 1899—.

Biennial publication containing sketches of living individuals, who themselves supply the information. (For persons dropped because of death there is a *Who Was Who*. *Who's Who in the East* and other sectional compilations include many additional names.)

- 11.16** O'Neill, Edward H. *A history of American biography, 1800-1935*. Philadelphia, 1935.

- 11.17** *Directory of American scholars, a biographical directory*. Ed. Jaques Cattell. 3d ed. N.Y., 1957.

Historians and scholars in the various fields of literature and the humanities

- 11.18** Doane, Gilbert H. *Searching for your ancestors*. [Rev. ed.] Minneapolis, 1948.

A guide to genealogical investigation. Methodology of genealogical research is considered also in George B. Everton, Sr., and Gunnar Rasmuson, *The Handy Book for Genealogists*, 3d ed., Logan, Utah, [1957]; Archibald F. Bennett, *A Guide for Genealogical Research*, Salt Lake City, 1951, and Jacques Barzun and Henry F. Graff, *The Modern Researcher*, N.Y., [1957]

- 11.19** The American genealogical-biographical index to American genealogical, biographical and local history materials. Middletown, Conn., 1952——.

The first 21 v. cover names from Aabrey to Bumpas only.

- 12.1** Ditzion, Sidney. "The history of periodical literature in the U.S.: a bibliography." *Bulletin of bibliography*, v. 15, pp 110, 129-133 (1935).

Incomplete and out of date, but occasionally useful. (Cf. bibliographies in section on Newspapers)

- 12.2** Gregory, Winifred. *Union list of serials in libraries of the U.S. and Canada*. 2d ed. N.Y., 1943.

This standard work locates files of magazines of all sorts. Many new files appear in supplements, published 1945 and 1953. For serials which commenced publication since 1949, see *New Serial Titles*, issued by the Library of Congress, 1956——. (American magazines 1741-1850 have been, or are in process of being, made available on microfilm, through University Microfilms, Inc., Ann Arbor, Mich. For annual lists of magazines, with circulation figures, see the N. W. Ayer annual, 13.8.)

- 12.3** Mott, Frank L. *A history of American magazines*. V. 1, 1741-1850; v. 2, 1850-1865; v. 3, 1865-1885; v. 4, 1885-1905. Cambridge, Mass., 1938-1957.

The standard work in its field. Various aspects of magazine journalism are discussed as a part of the social history of the times. Certain periodicals important in the period covered in a volume are given extended historical treatment in a supplementary section, and when such publications extend beyond the chronological limits of a volume, they are carried forward to their ends or to the date of publication of the volume. For example, in v. 4 the histories of the *Saturday Evening Post*, *Ladies Home Journal*, and *National Geographic* are carried down to 1957. (Mr. Mott is at work on v. 5.)

- 12.4** Tassin, Algernon. *The magazine in America*. N.Y., 1916.

Informal and out of date, but still probably the best of the single-volume histories for the use of students of literature.

- 12.5** Wood, James P. *Magazines in the U.S.* 2d ed. N.Y., [1956].

Suggestive for the period not as yet treated by Mott.

- 12.6** Peterson, Theodore. *Magazines in the twentieth century*. Urbana, Ill., 1956.

Covers American magazines of general circulation, with special emphasis on the advertising-production-circulation complex.

- 12.7** Richardson, Lyon N. *A history of early American magazines, 1741-1789.* N.Y., 1931.

- 12.13** Noel, Mary. *Villains galore.* N.Y., 1954.

History of popular 19th-century story weeklies like the N.Y. *Ledger*.

- 12.14** Ulrich, Carolyn, and Patterson, Eugenia. *Little magazines: a list.* N.Y., 1947.

Includes the periodicals in the N.Y. Public Library; period covered 1890-1946.

- 12.15** *Union list of little magazines.* Chicago, 1956.

A list of 1,037 little magazines in libraries of various Middle-Western universities, compiled under the auspices of Indiana University Library.

- 12.16** Hoffman, Frederick J., *et al.* *The little magazine: a history and a bibliography.* [2d ed.] Princeton, N.J., 1947.

13. NEWSPAPERS

- 13.1** Cannon, Carl L. *Journalism: a bibliography*. [N.Y.], 1924.

Chiefly works in English on various aspects of newspaperdom, primarily of the U.S.

- 13.2** Wolseley, Roland E. *The journalist's book shelf: an annotated and selected bibliography of U.S. journalism*. 6th ed. Chicago, 1955.

Begun in 1939 as a supplement to Cannon. Contains helpful lists of biographies of journalists and works on magazines as well as newspapers and the craft of writing for them.

- 13.3** *Journalism quarterly*. 1924——.

Since 1930 includes annotated bibliographies on various journalistic subjects.

- 13.4** *Editor & publisher international yearbook*. N.Y., 1920——.

Includes since 1936 a selective bibliography on journalistic matters.

- 13.5** Gregory, Winifred. *American newspapers 1821-1936, a union list of files available in the U.S. and Canada*. N.Y., 1937.

Rapidly being superseded by the numerous union lists covering newspaper files located in various cities, states, or regions.

- 13.6** Downs, Robert B., *et al.* *American library resources: a bibliographical guide*. Chicago, 1951.

Lists, among other materials, a limited number of published checklists of local holdings of newspapers and magazines. (There are numerous catalogs of newspapers of various states and localities as well as of holdings of individual libraries. Consult the card catalogue of your library under the name of state, locality, or special library.)

- 13.7** *Newspapers on microfilm*. 3d ed. Washington, 1957.

Chiefly American papers are listed, with the years for which microfilm has been made. Acknowledged to be incomplete. Additional reports of microfilmed newspapers appear in *Microfilming Clearing House Bulletin*, an occasional appendix to the Library of Congress, *Information Bulletin*.

- 13.8** N. W. Ayer & Son's directory of newspapers and periodicals Philadelphia, 1880——.

Lists annually, by state and city, newspapers and certain other periodicals published in the U.S. and Canada and supplies relevant information, including circulation, political affiliation, etc.

- 13.9** Rowell's American newspaper directory . . . 1869-1908. Ed. George P. Presbury. 40 v. in 61. N.Y., 1869-1908.

A list of papers and periodicals, with circulation figures, etc., long a rival of N. W. Ayer & Son's annual and in 1908 merged with it.

- 13.10** Mott, Frank L. American journalism: a history of newspapers in the U.S. through 260 years: 1690 to 1950. Rev. ed. N.Y., 1950.

Standard work on the history of American newspapers.

- 13.11** Lee, Alfred M. The daily newspaper in America. N.Y., 1937.

Emphasizes social and economic points of view.

- 13.12** Rosewater, Victor. History of coöperative news-gathering in the U.S. N.Y., 1930.

- 13.13** Watson, Elmo S. A history of newspaper syndicates in the U.S., 1865-1935. Chicago, 1936.

- 13.14** Brigham, Clarence S. History and bibliography of American newspapers 1690-1820. 2 v. Worcester, Mass., 1947.

The standard work for its period.

- 13.15** Schlesinger, Arthur M. Prelude to independence: the newspaper war on Britain 1764-1776. N.Y., 1958.

Contains much material on several papers of the times, including an appendix on their circulations.

- 13.16** Brayer, Herbert O. "Preliminary guide to indexed newspapers in the U.S., 1850-1900." Mississippi Valley historical review, v. 33, pp. 237-258 (September, 1946).

The indexes are often on cards. Repositories are indicated. Very incomplete.

- 13.17** New-York Daily Tribune index for 1875-1906. 31 v. N.Y., 1876-[1907].

- 13.18** The New York Times index. N.Y., 1913—.

There is also available a microfilm index of the contents of the *Times*, 1851-1905; 1905-1912 is in process of being filmed.

- 13.19** Press intelligence directory: a manual of newspaper content, local writers, and syndicated columnists. Washington, [1957].

Part II is a list of topics—e.g., book news, theater news—followed by selected examples of papers carrying such material and often supplying names of the local writers of it.

- 13.20** Detweiler, Frederick G. The Negro press in the U.S. Chicago, [1922].

- 13.21** Wittke, Carl. The German-language press in America. [Lexington, Ky., 1957].

Primarily a study in social history, not journalism.

The standard work on its subject.

Long out of date, but contains certain information not available elsewhere.

- 14.3** McMurtrie, Douglas C. A history of printing in the U.S.: Middle and South Atlantic States. N.Y., 1936.
Covers Pennsylvania, Maryland, New York, New Jersey, Delaware, District of Columbia, Virginia, South Carolina, North Carolina, and Georgia to 1800. (McMurtrie also edited a vast assortment of bibliographies listing the early imprints of various states and sections.)

- 14.4** Bowker lectures on book publishing. [Collected ed.] N.Y., 1957.
A reprint of the first 17 Bowker lectures, 1935-1956. A new lecture is given each year and is separately published.

- 14.5** Stern, Madeleine B. Imprints on history: book publishers and American frontiers. Bloomington, Ind., 1956.
Chiefly concerned with various regional publishers but contains also a list of 191 firms surviving from the era prior to 1900.

- 14.6** Shove, Raymond H. Cheap book production in the U.S., 1870 to 1891. Urbana, Ill., 1937.
Deals chiefly with works brought out in various series or "libraries" which were counterparts of the contemporary paperback series of reprints.

- 14.7** Shick, Frank L. The paperbound book in America and its European antecedents. N.Y., 1958.

- 14.8** Sheehan, Donald. This was publishing: a chronicle of the book trade in the Gilded Age. Bloomington, Ind., 1952.
From the Civil War to World War I; largely material on four firms: Holt, Harper, Scribner, Dodd, Mead. (There are, of course, many individual histories of various publishing companies.)

- 14.9** Cheney, O. H. *Economic survey of the book industry 1930-1931*. N.Y., 1931.

Reprinted in 1949 with a statistical report for 1947-1948.

- 14.10** Miller, William. *The book industry*. N.Y., 1949.

Commercial and editorial aspects of publishing, including relations with public libraries and book clubs.

- 14.11** Grannis, Chandler B., ed. *What happens in book publishing*. N.Y., 1957.

A group of specialists explain operations in the American book-publishing business, from securing of manuscripts and copy editing to university press, book clubs, paperback markets, and distribution of U.S. books abroad. Each chapter has a bibliography appended.

- 14.12** "Trends in American book publishing." *Library trends*, v. 7, no. 1 (July, 1958).

A series of essays by various authorities on recent developments in the several areas of publishing. Each essay is followed by a list of references. Frank L. Shick served as general editor of the issue.

- 14.13** Farrell, James T. "The fate of writing in America." *Literature and morality*. [N.Y., 1947]. See also 28.18.

Implications of present-day publishing and book distribution for serious writers.

- 14.14** *American book-prices current*. N.Y., 1895—.

Annual record of books, MSS, etc., sold at auction in N.Y., Boston, and Philadelphia, with records of prices paid. Various indexes of its contents have been published.

- 14.15** McKay, George L. *American book auction catalogues 1713-1934: a union list*. N.Y., 1937.

Supplements have appeared in the N.Y. Public Library *Bulletin*, v. 50 (1946) and v. 52 (1948). (The library of the American Antiquarian Society, Worcester, Mass., contains one of the largest collections of American book dealers' catalogs.)

- 14.16** *Private book collectors in the U.S. and Canada*. 9th rev. ed. N.Y., 1948.

One section arranges the collectors by their specialties—such as South-western Americana, drama, Mark Twain, Henry James. The list is incomplete.

- 14.17** Mott, Frank L. *Golden multitudes: the story of best sellers in the U.S.* N.Y., 1947.

A standard study.

- 14.18** Hart, James D. *The popular book: a history of America's literary taste*. N.Y., 1950.

Relates popular taste in reading to the "social pressures."

- 14.19** Hackett, Alice P. 60 years of best sellers, 1895-1955. N.Y., 1956.

Primarily lists of books; must be used with caution, for authentic figures on sales are often not available.

- 14.20** Kerr, Chester. A report on American university presses. [Washington], 1949.

Based on a survey conducted in 1948-1949. Brought nearer to date in a pamphlet by the same author, *American University Publishing 1955*, [Ann Arbor, Mich., 1956].

- 14.21** Welter, Rush. Problems of scholarly publication in the humanities and the social sciences. N.Y., [1959].

A factual report prepared for a committee of the American Council of Learned Societies; deals with periodicals as well as books.

A standard work on the history of ideas in the U.S. Special attention should be directed to its bibliography, which is both chronological and topical.

Literature is included, along with other factors in social history.

- 15.3** Horton, Rod W., and Edwards, Herbert W. Backgrounds of American literary thought. N.Y., [1952].

Elementary historical treatments of Puritanism, the Enlightenment, Transcendentalism, Evolution and Pragmatism, Gentility and Revolt, Imperialism, Naturalism, and Freudianism.

- 15.4** Parrington, Vernon L. Main currents in American thought 3 v. [N.Y., 1927-1930; 1954].

Survey of the political and social philosophy of American authors from Colonial times to about 1880. Last volume unfinished. (This work is often mistaken for a history of literature.)

- 15.5** Commager, Henry S. The American mind: an interpretation of American thought and character since the 1880's. New Haven, Conn., [1950; 1959].

Selected aspects of American thought are discussed, and a considerable portion is devoted to literature. To a certain degree this continues Parrington to the 1940's.

- 15.6** Wish, Harvey. Society and thought in America. 2 v. N.Y., 1950-1952.

A social and intellectual history.

- 15.7** Lerner, Max. America as a civilization: life and thought in the U.S. today. N.Y., 1957.

An attempt to grasp "the pattern and inner meaning of contemporary American civilization and its relation to the world of today." The bibliography adds many recent works to the record.

- 15.8** Persons, Stow. *American minds: a history of ideas.* N.Y., [1958].

An introduction to the history of American thought which describes "the principal focal concentrations of ideas," from the "colonial religious mind, 1620-1660" to the "contemporary neodemocratic mind." Very selective.

- 15.9** Beard, Charles A., and Beard, Mary R. *The American spirit: a study of the idea of civilization in the U.S.* N.Y., 1942.

This is v. 4 of a work entitled *The Rise of American Civilization*.

- 15.10** Dorfman, Joseph. *The economic mind in American civilization.* 5 v. N.Y., 1946-1959.

History of economic ideas, popular and technical, from 1606 to 1933.

- 15.11** Hofstadter, Richard. *Social Darwinism in American thought.* Rev. ed. N.Y., 1955; 1959.

- 15.12** Persons, Stow, ed. *Evolutionary thought in America.* New Haven, Conn., 1950; N.Y., 1956.

A symposium and bibliography.

- 15.13** Egbert, Donald D., and Persons, Stow, eds. *Socialism and American life.* 2 v. Princeton, N.J., 1952.

V. 1 is a symposium, including also outlines of European backgrounds; v. 2 is an uneven bibliography.

- 15.15** Hartz, Louis. *The liberal tradition in America: an interpretation of American political thought since the Revolution.* N.Y., [1955]

A suggestive hypothesis is outlined.

- 15.16** Rossiter, Clinton L. *Conservatism in America.* N.Y., 1955.

Includes a discussion of the contemporary "New Conservatism."

- 15.17** Wolfe, Don M. *The image of man in America.* Dallas, [1957].

Undertakes to show how thinkers, especially literary men, from Jefferson to Hemingway have answered questions about the nature of man. Occasionally suggestive.

- 15.18** Lewis, Richard W. B. *The American Adam: innocence, tragedy and tradition in the nineteenth century.* [Chicago, 1955; 1959].

"Tentative outlines of a native American mythology" as exhibited chiefly in certain aspects of literature. Rich with suggestions.

- 15.19** Lynn, Kenneth S. *The dream of success: a study of the modern American imagination.* Boston, [1955].

Dreiser, London, Phillips, Norris, and Herrick as affected by the "success myth." There is a chapter on Horatio Alger. Occasionally suggestive.

- 15.20** Jones, Howard M. *Ideas in America.* Cambridge, Mass., 1944.

Fugitive essays collected under three headings: "The Need for Literary History," "Studies in the History of Ideas in America," and "The Responsibilities of Contemporary American Literature."

From Colonial times to John Dewey.

Fullest account of the period 1867-1939. Chapters 17 and 18, on Neo-Realism and Critical Realism, are the most valuable portions.

- 16.5** Riley, I. Woodbridge. American thought from Puritanism to Pragmatism and beyond. 2d ed. N.Y., 1923.

- 16.6** Fisch, Max H., ed. Classic American philosophers. N.Y., [1951].

Scholarly anthology representing Peirce, James, Royce, Santayana, Dewey, and Whitehead.

- 16.7** Perry, Ralph B. The thought and character of William James. 2 v. Boston, 1935.

Provides the best means of getting the background for American philosophy in its most creative period. Reprinted in briefer form, Cambridge, Mass., 1948.

- 16.8** Riley, I. Woodbridge. American philosophy: the early schools. N.Y., 1907; 1958.

Out of date but suggestive.

- 16.9** Curti, Merle. "The great Mr. Locke: America's philosopher, 1783-1861." Huntington Library bulletin, no. 11, pp. 107-157 (April, 1937).

- 16.10** Adams, George P., and Montague, William P., eds. Contemporary American philosophy: personal statements. 2 v. London and N.Y., [1930].

Statements of belief by 34 philosophers.

Statements of belief by 25 thinkers.

Written by a clinician whose personal experiences enter into his record of events.
- 16.17** Fay, Jay W. *American psychology before William James*. New Brunswick, N. J., 1939.
- 16.18** Davies, John D. *Phrenology: fad and science: a 19th-century American crusade*. New Haven, Conn., 1955.
(Poe, Whitman, and other writers of their day were greatly influenced by phrenology.)

17. TRANSCENDENTALISM IN THE U.S.

A well-rounded account of Transcendentalism in its chief manifestation. The bibliography is the most adequate one on the subject.

An excellent account of 19th-century developments, with a special chapter on "Unitarianism and Literature." Provides a neat history of the emergence of Transcendentalism.

- 17.3** Wilbur, Earl M. A history of Unitarianism in Transylvania, England, and America. Cambridge, Mass., 1952.

- 17.4** Frothingham, Octavius B. Transcendentalism in New England: a history. N.Y., 1876; 1959.

- 17.5** Goddard, Harold C. Studies in New England transcendentalism. N.Y., 1908.

- 17.6** Ellis, Charles M. An essay on transcendentalism (1842). Ed. Walter Harding. Gainesville, Fla., 1954.

A reprint of one of the better treatments emanating from the 1840's.

- 17.7** Miller, Perry, ed. The American transcendentalists, their prose and poetry. Cambridge, Mass., 1950; Garden City, N.Y., 1957.

An anthology with a suggestive introduction. The first edition bears the title *The Transcendentalists: An Anthology*.

Deals with the very important influence of Victor Cousin and other Frenchmen.

- 17.10** Persons, Stow. Free religion, an American faith. New Haven, Conn., 1947.

(Free religion eventually absorbed many of the later Transcendentalists.)

Contains, pp. 173-207, a list of works dealing with the religious history of the U.S. (Further out of date is Peter G. Mode, *Source Book and Bibliographical Guide for American Church History*, Menasha, Wis., [1921].)

- 18.3** Sweet, William W. The story of religion in America. [2d rev. ed.] N.Y., [1950].

The chief general history, but a sadly inadequate one. The same author's *Religion in Colonial America*, N.Y., 1942, and *Religion in the Development of American Culture, 1765-1840*, N.Y., 1952, are preferable to the corresponding portions of *The Story*.

- 18.4** Morais, Herbert M. Deism in eighteenth century America. N.Y., 1934.

- 18.5** Koch, G. Adolf. Republican religion: the American Revolution and the cult of reason. N.Y., [1933].

Deism and the reaction against it.

- 18.6** Billington, Ray A. The Protestant crusade, 1800-1860: a study of the origins of American nativism. N.Y., 1938.

Treats the opposition to Catholicism which was part of the Know-Nothing movement.

- 18.7** Post, Albert. Popular freethought in America 1825-1850. N.Y., 1943.

- 18.8** Warren, Sidney. American freethought, 1860-1914. N.Y., 1943.

- 18.9** Hopkins, Charles H. The rise of the social gospel in American Protestantism 1865-1915. New Haven, Conn., 1940.

Deals with the "progressive" theology and sociological tendencies resulting from the impact of industrial society and scientific theories.

- 18.10** Garrison, Winfred E. *The march of faith: the story of religion in America since 1865.* N.Y., 1933.

Represents a species of social history emphasizing changes within denominational lines.

- 18.11** Schneider, Herbert W. *Religion in 20th century America.* Cambridge, Mass., 1952.

A volume in the Library of Congress series in American Civilization; useful for suggestions.

- 18.12** Ellis, John T. *Documents of American Catholic history.* Milwaukee, [1956].

- 18.13** Mead, Frank S. *Handbook of denominations in the U.S.* Rev. ed. N.Y., [1956].

Brief sketches of 200-odd sects or denominations. (Annual statistics appear in *Yearbook of the Churches*, published by the National Council of the Churches of Christ in the U.S.A.)

- 18.14** Mayer, Frederick E. *The religious bodies of America.* St. Louis, [1954].

Various denominations are treated from the angle of their theology; bibliographies are appended to each section; intended "primarily for the theological student and the parish minister."

- 18.15** Stewart, Randall. *American literature & Christian doctrine.* Baton Rouge, La., [1958].

A tentative exploration of several authors and literary traditions in terms of their religious ideas.

Treats, in an old-fashioned way, Bryant, Emerson, Whittier, Poe, Longfellow, Lowell, Holmes, Lanier, and Whitman.

- 18.17** Luccock, Halford E. *Contemporary American literature and religion.* Chicago, 1934.

Occasionally suggestive.

- 18.18** Luccock, Halford E. *American mirror: social, ethical and religious aspects of American literature, 1930-1940.* N.Y., 1940.

A sequel to the preceding item.

Standard bibliography for the several fine arts.

Introductory survey of the history of architecture, sculpture, painting, and, sporadically, the minor arts; intended for the use of students of American Civilization. Bibliographies and illustrations add value. (The Archives of American Art, housed in the Detroit Institute of Arts, is collecting in one central place records of American painters, sculptors, and craftsmen, such as original and microfilm source materials, biographies, catalogs, and photographs of works of art.)

- 19.3** Mumford, Lewis. *The brown decades: a study of the arts in America, 1865-1895*. 2d rev. ed. N.Y., [1955].

Useful largely as an over-all interpretation of the period.

- 19.4** Groce, George C., and Wallace, David H. *The New-York Historical Society's dictionary of artists in America, 1564-1860*. New Haven, Conn., 1957.

Biographical dictionary of painters, sculptors, engravers, etc., amateur and professional, to 1860.

- 19.5** Christensen, Erwin O. *The index of American design*. Washington, 1950; N.Y., 1950; 1959.

Describes and reproduces numerous examples of the holdings of the Index of American Design, which is a collection of WPA drawings and paintings of a vast variety of products of crafts and folk art, now housed in the National Gallery of Art in Washington.

- 19.6** Barker, Virgil. *American painting: history and interpretation*. N.Y., 1950.

Ends about 1900 with the work of Homer, Ryder, and Eakins. (The Frick Art Reference Library, in New York, is the leading research library in its field.)

- 19.7** Richardson, Edgar P. *Painting in America: the story of 450 years.* N.Y., [1956].

The appended selective bibliography makes a special point of museum exhibition catalogs, which often contain reproductions of pictures.

- 19.8** Monro, Isabel S., and Monro, Kate M. *Index to reproductions of American paintings: a guide to pictures occurring in more than eight hundred books.* N.Y., 1948.

Occasionally locates the paintings in the permanent collections which house them.

- 19.9** Dunlap, William. *A history of the rise and progress of the arts of design in the U.S.* New ed. 3 v. Boston, 1918.

Originally published in 1834, this is still valuable because of its first-hand accounts of artists of the late 18th and early 19th centuries.

- 19.10** Brown, Milton W. *American painting from the Armory Show to the Depression.* Princeton, N.J., 1955.

A history, chiefly of the realists, from the Ash Can School to the new realism illustrated by T. H. Benton.

- 19.11** Janis, Sidney. *Abstract & surrealist art in America.* N.Y., [1944].

- 19.12** Weitenkampf, Frank. *American graphic art.* New ed. N.Y., 1924. Engraving and book illustration.

- 19.13** Murrell, William. *A history of American graphic humor.* 2 v. N.Y., 1933-1938.

Covers the chief cartoonists 1747-1938.

- 19.14** Nevins, Allan, and Weitenkampf, Frank. *A century of political cartoons: caricature in the U.S. from 1800 to 1900.* N.Y., 1944.

Sculpture

- 19.15** McCausland, Elizabeth. "A selected bibliography on American painting and sculpture from Colonial times to the present." *Magazine of art*, v. 4, pp. 329-349 (November, 1946).

An uncritical checklist; reprinted in *Who's Who in American Art*, Washington, 1947, v. 4, pp. 611-653.

- 19.16** Proske, Beatrice G. *Brookgreen Gardens sculpture.* Brookgreen, S.C., 1943.

Contains brief sketches and bibliographies of many sculptors 1870-1940.

- 19.17** Taft, Lorado. *The history of American sculpture.* New ed. N.Y., 1930.

Taft was a sculptor—not a historian.

- 19.18** Schnier, Jacques P. *Sculpture in modern America.* Berkeley, Calif., 1948.

Architecture

- 19.19** Andrews, Wayne. *Architecture, ambition and Americans: a history of American architecture, from the beginning to the present.* N.Y., [1955].
- 19.20** Tallmadge, Thomas E. *The story of architecture in America.* Rev. ed. N.Y., [1936].
- 19.21** Giedion, Sigfried. *Space, time, and architecture: the growth of a new tradition.* 3d ed. enlarged. Cambridge, Mass., 1954.
Covers the western world from the 17th century to date, but the sections on the U.S. in the 19th and 20th centuries are valuable; discusses also city planning.
- 19.22** Morrison, Hugh. *Early American architecture: from the first Colonial settlements to the national period.* N.Y., 1952.
Standard work, covering the eastern colonies to the time of the Revolutionary War, French Louisiana to 1803, and the Spanish colonies to 1848.
- 19.23** Hamlin, Talbot F. *Greek revival architecture in America.* London and N.Y., 1944.
For the earlier 19th century.
- 19.24** Upjohn, Everard M. *Richard Upjohn, architect and churchman.* N.Y., 1939.
Contains considerable background material.
- 19.25** Hitchcock, Henry R. *The architecture of H. H. Richardson and his times.* N.Y., 1936.
- 19.26** Scully, Vincent J. *The shingle style: architectural theory and design from Richardson to the origins of Wright.* New Haven, Conn., 1955.

Gives emphasis to recent technological improvements.

Thirty-seven essays by 29 writers, from mid-nineteenth century to 1950, having to do with the theory and philosophy of architecture.

This is the most adequate general history of the subject; it may be generally supplemented by Chase.

Supplements Howard from time to time, and its approach is different.

- 19.31** Mueller, John H. *The American symphony orchestra: a social history of musical taste.* Bloomington, Ind., 1951.
- 19.32** Hipsher, Edward E. *American opera and its composers.* Philadelphia, [1934].
 Surveys the history of serious opera and offers a "summary of the lighter forms which led up to its birth."
- 19.33** Mattfeld, Julius. *Variety music cavalcade, 1620-1950: a chronology of vocal and instrumental music popular in the U.S.* N.Y., [1952].
- 19.34** Spaeth, Sigmund G. *A history of popular music in America.* N.Y., [1948].
 From Colonial times to the 1940's.
- 19.35** Ames, Russell. *The story of American folk song.* N.Y., [1955].
 (See also the section on Folklore.)
- 19.36** Barry, Phillips. *Folk music in America.* [N.Y.], 1939.
 A WPA mimeographed work issued by the National Service Bureau.
- 19.37** Stearns, Marshall W. *The story of jazz.* N.Y., 1956.
 Includes bibliographical references.
- 19.38** American Society of Composers, Authors and Publishers. *The ASCAP biographical dictionary of composers, authors, and publishers.* Ed. Daniel I. McNamara. 2d ed. N.Y., [1952].
- 19.39** Reis, Claire. *Composers in America: biographical sketches of contemporary composers with a record of their works, 1912-1937.* Rev. ed. N.Y., 1947.
- 19.40** Smith, Cecil M. *Worlds of music.* Philadelphia, [1952].
 Music as a business: concert management, touring performers, etc.
- 19.41** Barzun, Jacques. *Music in American life.* N.Y., 1956.
 A popular treatise dealing with the present day, not the past.

20. CHIEF GENERAL BIBLIOGRAPHIES OF AMERICAN LITERATURE

- 20.1** Johnson, Thomas H., ed. *Literary history of the U.S.* v. 3. N.Y., 1948; 1953.

The third volume of a standard history, this is exclusively devoted to bibliography. It is the most extensive bibliography of its subject and has a special section treating separately a considerable number of individual authors. Very well arranged but insufficiently indexed. The following item is a supplement.

- 20.2** Ludwig, Richard M., ed. *Literary history of the U.S.: bibliography supplement*. N.Y., 1959.

A supplement to v. 3 of *LHUS* which assembles new material published since 1948 and adds comprehensive bibliographies of 16 new authors.

- 20.3** Quinn, Arthur H., ed. *The literature of the American people: an historical and critical survey*. N.Y., [1951].

Contains a 120-page bibliography with critical comments, prepared by the four authors of the volume.

- 20.4** *The Cambridge history of American literature*. Ed. W. P. Trent *et al.* 4 v. N.Y., 1917-1921.

Bibliographies, arranged by chapters, appear at end of v. 1, 2, and 4. Both text and bibliographies are often, but not always, outmoded, especially as they concern major figures. In 1944 the three volumes were reprinted in one, without the bibliographies.

- 20.5** Leary, Lewis G. *Articles on American literature 1900-1950*. Durham, N.C., 1954.

Conflates lists from *PMLA*, *American Literature*, and other sources. (For articles since 1950, see *PMLA* annual bibliography and the quarterly checklists in *American Literature*.)

- 20.6** *American literature*. 1929——.

The chief journal in its field, published quarterly by the Duke University Press, with the co-operation of the American Literature Group of the Modern Language Association of America. Contains articles of an historical, critical, or bibliographical sort, book reviews, lists of dissertations completed or in progress and an annotated checklist of current periodical articles. (To 1951 the articles listed in its bibliography have been conflated in Leary.)

- 20.7** Marshall, Thomas F. *An analytical index to American Literature*, v. 1-20 (March, 1929—January, 1949). Durham, N. C., 1954.

Indexes by author and subject the articles published in the journal and the chief books reviewed in it.

- 20.8** "American bibliography for 1921——." *PMLA*, v. 37——, 1922——.

Annual listing of books and articles on various modern European languages and literatures; until 1957 largely limited to works by Americans. Carries regularly a special section on American literature.

- 20.9** Woodress, James. *Dissertations in American literature 1891-1955*. Durham, N.C., 1957.

A classified list of doctoral dissertations from about 100 universities at home and abroad, including an incomplete listing of those in progress prior to 1956. (For more recent dissertations, see the lists published quarterly in *American Literature*.)

- 20.10** American writers series. General editor, Harry H. Clark. N.Y., etc., [1934-1950].

A series of textbooks, most of which are devoted to individual authors, from Edwards and Franklin to Harte and James; selected writings plus carefully prepared introductions and annotated selective bibliographies. Various scholars edited the several volumes. To the date of their publication the bibliographies are exceptionally well chosen from the supply of both books and articles.

- 20.11** Blanck, Jacob. *Bibliography of American literature*. 8 or 9 v. planned. New Haven, Conn., 1955——.

Descriptive bibliographies of all first editions and various other separates of about 300 authors of belles-lettres who died before 1931. A most accurate work, with invaluable lists. Locates copies in selected libraries. The first volume covers 41 authors, Henry Adams to Donn Byrne; the second (1957), 45 authors, G. W. Cable to Timothy Dwight; v. 3 (1959) through Harte.

- 20.12** Johnson, Merle D. *American first editions*. 4th ed. Rev. and enlarged by Jacob Blanck. N.Y., 1942.

Lists the chief first editions of 194 American authors of the 19th and 20th centuries. The 1936 edition contained 24 authors omitted from this one, including Ray S. Baker, Zona Gale, Mary N. Murfree, D. G. Phillips, Upton Sinclair. Will eventually be wholly displaced by Blanck.

- 20.13** Foley, Patrick K. *American authors 1795-1895: a bibliography of first and notable editions chronologically arranged with notes*. Boston, 1897.

Still useful for works by certain minor authors.

- 20.14** Jones, Joseph, *et al.* *American literary manuscripts*.

A calendar of the holdings of various libraries, prepared by a committee of the American Literature Group of the MLA and scheduled for publication by the University of Texas Press in 1960. (Queries about the location of the manuscripts may be directed meanwhile to Professor Jones, 123 English Building, Univ. of Texas, Austin.)

- 20.15** Northup, Clark S. A register of bibliographies of the English language and literature. New Haven, Conn., 1925.

Includes various American authors and topics, such as Negro literature, printing and publishing, local literature.

- 20.16** Van Patten, Nathan. An index to bibliographies and bibliographical contributions relating to the work of American and British authors, 1923-1932. Stanford, Calif., 1934.

Works included were printed 1923-1932, plus a very few from 1933.

- 20.17** Stovall, Floyd, ed. Eight American authors, a review of research and criticism. N.Y., 1956.

An excellent bibliographical survey of studies on Poe, Emerson, Hawthorne, Thoreau, Melville, Whitman, Mark Twain, and Henry James. Each of the 8 authors is treated by a distinguished scholar.

- 20.18** Spargo, John W. A bibliographical manual for students of the language and literature of England and the U.S.: a short-title list. 3d ed. N.Y., 1956.

Deals primarily with English literature and is out of date. (Two similar manuals are: Tom P. Cross, *Bibliographical Guide to English Studies*, 10th ed., Chicago, [1956]; and Arthur G. Kennedy, *A Concise Bibliography for Students of English Systematically Arranged*, 3d ed., Stanford, Calif., [1954; 1957].)

- 20.19** Contemporary literary scholarship: a critical review. Ed. Lewis Leary for a committee of the National Council of Teachers of English. N.Y., [1958].

Brief surveys, by various hands, of recent publications in the fields of English, comparative, and American literature. The material on Americana, a minority element in the book, must be used with caution, for there are many gaps in information and the critical appraisals are sometimes rather partisan.

21. CHIEF GENERAL HISTORIES AND SELECTED CRITICAL DISCUSSIONS OF AMERICAN LITERATURE

- 21.1** Crawford, Bartholow V., *et al.* American literature. 3d ed. N.Y., [1953; 1957].

An outline of the history of American literature. Earlier editions bear the title *An Outline-History of American Literature*.

- 21.2** Literary history of the U.S. Ed. Robert E. Spiller, Willard Thorp, Thomas H. Johnson, *et al.* 3 v. N.Y., 1948.

Usually referred to as *LHUS*. Fifty-five authors contributed one or more chapters, which vary in quality but make up the most extensive academic history of the subject. The third volume is exclusively devoted to bibliography.

- 21.3** Literary history of the U.S. Ed. Robert E. Spiller *et al.* Rev. ed. in one v. N.Y., 1953.

A new chapter, "Postscript at Mid-century," and a 23-page bibliography for the general reader represent the chief changes. V. 3 of the 1948 edition is not reprinted.

- 21.4** Quinn, Arthur H., ed. The literature of the American people: an historical and critical survey. N.Y., [1951].

Written by four scholars, Kenneth B. Murdock, Arthur H. Quinn, Clarence Gohdes, and George F. Whicher, this is in method the most scholarly narrative of the literature of the U.S.

- 21.5** Spiller, Robert E. The cycle of American literature. N.Y., 1955; 1957.

An excellent short history, along with a partial elaboration of a theory of cycles.

- 21.6** Taylor, Walter F. The story of American letters. Chicago, 1956.

Revised edition of an historical survey originally [1936] entitled *A History of American Letters*. Uses the Colonial period merely as a point of departure and ends with authors established at the time of World War II.

- 21.7** Blankenship, Russell. American literature as an expression of the national mind. Rev. ed. N.Y., [1949].

A readable brief history strongly influenced by Vernon Parrington (15.4).

- 21.8** Lüdeke, Henry. *Geschichte der amerikanischen Literatur*. Bern, [1952].

The most consequential history of its subject ever written by a foreigner; especially valuable for its references to German backgrounds. A revised edition is in prospect.

- 21.9** Arnavon, Cyrille. *Histoire littéraire des États-Unis*. [Paris, 1953].

Best general history of the subject written by a Frenchman.

- 21.10** Cunliffe, Marcus. *The literature of the U.S.* London, etc., [1954].

A brief account, written by an Englishman, useful for occasional criticisms.

- 21.11** Brooks, Van Wyck. *Makers and finders: a history of the writer in America, 1800-1915*.

A series of 5 v. containing a well-written, impressionistic history in which many minor writers are interwoven. The scholar usually finds the treatment of the minor authors more rewarding factually than the discussion of the major figures. As a venture in criticism in the broader sense, the series is the most extensive as well as the most brilliantly written survey of its subject ever produced by a single author. The 5 v. in the order of coverage are: *The World of Washington Irving*, N.Y., [1944]; *The Flowering of New England, 1815-1865*, new and rev. ed., N.Y., 1937; *The Times of Melville and Whitman*, N.Y., 1947; *New England: Indian Summer, 1865-1915*, N.Y., 1940, *The Confident Years: 1885-1915*, N.Y., 1952. All of these have been reprinted, e.g., in Everyman's Library.

- 21.12** Pattee, Fred L. *A history of American literature since 1870*. N.Y., 1915.

Still very helpful, though it must be used in connection with the following item.

- 21.13** Pattee, Fred L. *The new American literature, 1890-1930*. N.Y., [1930].

A vigorous critical and historical account. In certain cases this reassesses authors and works published prior to 1890.

- 21.14** Foerster, Norman, ed. *The reinterpretation of American literature*. N.Y., 1928; 1959.

Contains essays on the influence of Puritanism, the frontier, etc. This work was very influential on the academic study of American literature for a number of years.

- 21.15** Clark, Harry H., ed. *Transitions in American literary history*. Durham, N.C., 1953.

A symposium of 7 exploratory essays, by various scholars, on "The Decline of Puritanism," "The Late Eighteenth Century," "The Decline of Neoclassicism," "The Rise of Romanticism," "The Rise of Transcendentalism," "The Decline of Romantic Idealism," and "The Rise of Realism 1871-1891."

- 21.16** Hart, James D. *The Oxford companion to American literature*. 3d ed. N.Y., 1956.

The standard handbook; includes sketches of authors and magazines, outlines of plots, explanations of movements and terminology.

- 21.17** Wilson, Edmund, ed. *The shock of recognition: the development of literature in the U.S. recorded by the men who made it.* 2 v. N.Y., [1955].

A collection of literary documents by distinguished American authors commenting on other authors. V. 1 covers 1845-1900; v. 2 the 20th century.

- 21.18** Howells, William D. *Literary friends and acquaintance: a personal retrospect of American authorship.* N.Y., 1900; 1902.

Contains much first-hand material on Boston and New York as literary centers 1860-1900 and presents invaluable portraits of Holmes, Longfellow, and Lowell in old age.

- 21.19** Garland, Hamlin. *Roadside meetings.* N.Y., 1930; *Companions on the trail.* N.Y., 1931; *My friendly contemporaries.* N.Y., 1932; *Afternoon neighbors.* N.Y., 1934.

A series of recollections of authors and literary history covering "the purely literary side" of Garland's experiences during the period 1885-1930.

- 21.20** Knight, Grant C. *The critical period in American literature.* Chapel Hill, N.C., [1951].

Literary history of the decade 1890-1900. (For a sequel covering the following decade, see 28.8.)

- 21.21** Macy, John, ed. *American writers on American literature.* N.Y., [1931].

Thirty-seven writers contributed a chapter each, on an important author or topic like Colonial historians or contemporary poetry. One of the better ventures of the sort.

- 21.22** Matthiessen, Francis O. *American renaissance.* N.Y., [1941; 1957].

A standard critical study concerned with Emerson, Hawthorne, Melville, Thoreau and Whitman.

- 21.23** Brownell, William C. *American prose masters.* N.Y., 1909.

Discriminating essays on Cooper, Hawthorne, Emerson, Poe, Lowell, and Henry James.

- 21.24** Miller, Perry. *The raven and the whale: the war of words and wits in the era of Poe and Melville.* N.Y., [1956].

- 21.25** University of Minnesota pamphlets on American writers. Ed. William V. O'Connor *et al.* Minneapolis, 1959—.

A series of brief pamphlets each dealing with a single author and containing biography, "simple, easily got at critical introductions," and bibliography of the author's books and of articles and books about him. The pamphlets are prepared by various critics, chiefly college professors.

Indexes contents of 577 anthologies of verse by title of poem and first line, author, and subject. Principally British and American poetry. A supplement, 1957, adds 77 new collections and 11 new editions.

- 22.2** Kreymborg, Alfred. A history of American poetry: our singing strength. N.Y., 1934.

In 1929 this book appeared under the title *Our Singing Strength*. To be used with caution.

- 22.3** Allen, Gay W. American prosody. N.Y., [1935].

Versification of 11 poets, from Freneau to Emily Dickinson.

- 22.4** Wells, Henry W. The American way of poetry. N.Y., 1943.

Uneven survey of the "indigenous and unique," with good critical chapters on Freneau, Whitman, Emerson, Emily Dickinson, *et al.*

- 22.5** Arms, George, and Kuntz, Joseph M. Poetry explication: a checklist of interpretation since 1925 of British and American poems past and present. [N.Y.], 1950.

(A periodical entitled the *Explicator*, 1942—, is especially devoted to "explication"; a considerable portion of the poems treated is American. The June issues contain an annual checklist of "explication.")

- 22.6** Hastings, Henry C. Spoken poetry on records and tapes: an index of currently available recordings. Chicago, 1957.

- 22.7** Conner, Frederick W. Cosmic optimism: a study of the interpretation of evolution by American poets from Emerson to Robinson. Gainesville, Fla., 1949.

- 22.8** Lenhart, Charmerz S. Musical influence on American poetry. Athens, Ga., [1956].

Incomplete list of volumes of verse, 1650-1820.

- 22.10** Arms, George. The fields were green: a new view of Bryant, Whittier, Holmes, Lowell, and Longfellow, with a selection of their poems. Stanford, Calif., [1953].

- 22.11** Kindilien, Carlin T. *American poetry in the eighteen nineties*. Providence, R.I., 1956

Based on the Harris Collection at Brown University, which is one of the largest special collections of poetry of the U.S.

Poetry, 20th Century

Lists chronologically by year of publication 6,906 books of verse.

- 22.13** "American poetry: 1930-1940 " *Accent*, v. 1, pp. 213-228 (Summer, 1941).

Records "notable books of poetry and about poetry" published year by year in the U.S.

- 22.14** Tate, Allen. *Sixty American poets 1896-1944*. Rev. ed. Washington, 1954.

Lists selected books by and about the poets.

- 22.15** Braithwaite, William S.B., ed. *Anthology of magazine verse for 1913-1929, and yearbook of American poetry*. N.Y., [1913]-1929.

- 22.16** Shapiro, Karl. *A bibliography of modern prosody*. Baltimore, 1948.

English and American books and articles are listed with brief comments on their contents. Only a few items are earlier than the 20th century.

- 22.17** Gregory, Horace, and Zaturenska, Marya. *A history of American poetry, 1900-1940*. N.Y., [1946].

Written by poets, not scholars.

- 22.18** Untermeyer, Louis. *American poetry since 1900*. N.Y., 1923.

- 22.19** Rittenhouse, Jessie B. *The younger American poets*. Boston, 1906.

- 22.20** Lowell, Amy. *Tendencies in modern American poetry*. Boston, [1927].

Robinson, Frost, Masters, Sandburg, H. D., and Fletcher.

- 22.21** Coffman, Stanley K. *Imagism: a chapter for the history of modern poetry*. Norman, Okla., [1951].

- 22.22** Hughes, Glenn. *Imagism & the imagists*. Stanford, Calif., 1931.

- 22.23** Wells, Henry W. *New poets from old*. N Y . 1940.

The relationship of 20th-century poets, chiefly American, with older traditions in English verse.

Lists published plays written chiefly by British and American authors. (*Play Index: 1949-1952*, comp Dorothy H. West and Dorothy M. Peake, N.Y., 1953, is a kind of sequel)

- 23.3** Hill, Frank P. American plays printed 1714-1830 a bibliographical record. Stanford, Calif., [1934].

- 23.4** Wegelin, Oscar. Early American plays, 1714-1830. 2d rev. ed. N.Y., 1905.

A list of titles of plays and dramatic poems.

- 23.5** Roden, Robert F. Later American plays, 1831-1900. N.Y., 1900.

Very incomplete catalogue.

- 23.6** Dramatic compositions copyrighted in the U.S., 1870 to 1916. 2 v. Washington, 1918.

About 60,000 plays registered for copyright. (For titles of plays etc copyrighted since 1916, see U.S. Copyright Office catalog of copyright entries.)

- 23.7** America's lost plays. 20 v. Princeton, N.J., 1940-1942.

A series of previously unpublished plays by a variety of authors.

- 23.8** The best plays of 1894-1899. Ed. John Chapman and Garrison P. Sherwood. N.Y., 1955.

A brief listing to bridge the gap between Odell and the following.

- 23.9** The best plays of 1899-1909 and the year book of the drama in America. Ed. Burns Mantle and Garrison P. Sherwood. N.Y., 1944.

- 23.10** The best plays of 1909——. N.Y., 1910——.

Has been continued to date in a series, variously edited, of annual supplements. These contain abridged texts of selected plays, lists of others performed or published, and a variety of other information.

- 23.11** Hartnoll, Phyllis, ed. *The Oxford companion to the theatre*. Rev. ed. London, 1957.

Contains many entries on American theaters, playwrights, producers, etc.

- 23.12** A bibliography on theatre and drama in American colleges and universities 1937-1947. *Speech monographs*, v. 16, no. 3 (November, 1949).

Includes books, articles, dissertations, and master's essays.

- 23.13** *The drama*. 21 v. Chicago, 1911-1931.

- 23.14** *Theatre magazine*. 53 v. N.Y., 1900-1931.

- 23.15** *Theatre arts monthly: a magazine for the world theatre*. 1916——.

March issues contain annual bibliographies, covering principally North and South America. (Other folklore journals of the U.S. include *Midwest Folklore*, *New Mexico Folklore Record*, *New York Folklore Quarterly*, *Tennessee Folklore Society Bulletin*, and *Western Folklore*. *Texas Folklore Society Publications* is a series of volumes.)

An analytical index covering the contents of this journal to 1958 appeared in 1958, by Tristram P. Coffin.

Co-operating nations report translations of books to UNESCO, which periodically issues this list. Record incomplete.

- 35.4** Revue de littérature comparée. 1921——.

Each issue contains a bibliography of its subject and now includes a special section on North American influences.

- 35.5** Comparative literature. 1949——.

Chief American journal in its field.

- 35.6** Van Tieghem, Paul. La littérature comparée. 2d ed. Paris, 1939.

A standard work for the French school of comparatists.

- 35.7** Friederich, Werner P., and Malone, David H. Outline of comparative literature from Dante Alighieri to Eugene O'Neill. Chapel Hill, N.C., 1954.

An elementary but neat outline, with emphasis on literary influences.

- 35.8** Hopper, Vincent F., and Grebanier, Bernard D. N. Bibliography of European literature. Brooklyn, N.Y., [1954].

Selected books in English on various aspects of the literary history of Europe, from the Middle Ages to the present century, including biographies, critical studies, and translations of the major authors.

- 35.9** Van Tieghem, Paul. Outline of the literary history of Europe since the Renaissance. Translated by Aimee L. McKenzie. N.Y., [1930].

General terms, like *expressionism* and *symbolism*, are defined; important works are outlined; a limited group of literary characters are sketched; and a very considerable number of authors are provided with biographical accounts. Works synopsized are alphabetized according to the Italian translations, not original titles.

- 35.12** Frauwallner, Erich, *et al.* Die Weltliteratur. 3 v. Vienna, [1951-1954].

Encyclopaedia covering earliest times to 1951, articles on national literatures, literary forms, eminent authors; alphabetically arranged. The bibliographies sometimes help pick up stray works on American authors published in Europe, especially Austria.

- 35.13** Eppelsheimer, Hanns W. Handbuch der Weltliteratur. 2 v. Frankfurt am Main, [1947-1950].

V. 1 covers beginnings through the 18th century; v. 2 surveys various national literatures for the 19th century and 20th century separately.

- 35.14** Magnus, Laurie. A dictionary of European literature, designed as a companion to English studies. 2d revision. London and N.Y., 1927.

- 35.15** Smith, Horatio, ed. Columbia dictionary of modern European literature. N.Y., 1947.

Continental authors and literature from about 1870 to 1940.
